## MEMBERSHIP POLICIES

Welcome to Breton Bay Golf and Country Club. We are dedicated to providing quality recreational facilities for your enjoyment. As we strive to improve our facilities, your support will ensure our continued success.

Breton Bay Recreation, Inc. manages and operates the recreational facilities of Breton Bay Golf and Country Club. The Corporation is publicly held and is governed by an elected 9- member Board of Directors. The Breton Bay recreational facilities consist of a golf course, clubhouse, tennis courts and aquatic facility. Operation of the recreational facilities is the responsibility of Mr. Dave Eaton, PGA, our General Manager/Director of Golf, under the direction of the Board of Directors.

Club member committees and associations may be stood up at any time for golf, swim, tennis, and social activities. The committees plan and conduct special recreational and social functions for our members. They also provide an opportunity for members to express concerns and to provide recommendations to Club management on issues related to operation of the facilities and activities. Activities sponsored by club member committees and associations are subject to approval by the General Manager. Each committee chairman will report directly to the appropriate manager. Each committee will be responsible for submitting its plans, schedules and budget requirements to the General Manager. Member participation in committees and associations is encouraged.

The aquatic facility and tennis courts are open to members only, their paying guests, and employees. To participate in swim team, swim lessons and/or tennis camp, a swim/tennis membership is required. Special functions such as tournaments, special classes, swim meets, or other functions that permit member and non-member utilization of these facilities are permitted upon approval by the respective managers. Exclusive use of the swim and tennis facilities by groups of individuals may be permitted by the swim or tennis managers as deemed in the best interests of the Club. An appropriate fee, established by the General Manager, may be charged for such events.

The golf course is open to the general public. The golf course is also available for use (including exclusive use) by groups of individuals (member or non-member) at such times as deemed by the General Manager as in the best interest of the Club. Exclusive use of the golf course by non-member groups (in which members or other patrons are not permitted use of the golf course) is discouraged on Fridays and before noon on Saturdays, Sundays and Holidays. Junior golf summer camp is open to the public. Tournaments, which require restricted use/closing of the golf course, are scheduled and approved by the General Manager.

The Ironwood Grill is open to the general public. Exclusive use functions may be scheduled in the Ironwood Grill by both member and non-member groups subject to approval by the General Manager.



## MEMBERSHIP POLICIES

Bikes, skateboards, and personal motorized vehicles are not permitted on the golf course, pool deck, or tennis courts at any time. Bikes, skateboards, and personal motorized vehicles are permitted on club property (parking lots and roadways) only as a means of transportation to club facilities, not for personal recreation. Fishing in golf course owned ponds is prohibited at all times.

Rules of use and operation of the recreational facilities are the responsibility of the General Manager. Working with the committee chairs, Maintenance Superintendent, and other managers, the General Manager has the authority to approve exception to such rules as deemed appropriate.

Club members are afforded certain privileges that are not available to non-members. The following are afforded to our members:

Exclusive participation in Club sponsored "members only" recreational and social events.

Priority for membership in the Men's and Ladies' Golf Associations, Social committees, and participation in the summer Youth Programs (Breton Bay Swim Team, Swim Lessons, and Tennis Camp).

Members in good standing with a credit card on file may charge cart fees, guest fees, Ironwood Grill purchases, and Pro Shop merchandise to their accounts. Members may also charge snacks at the pool. All charges are billed the last day of the month in which the charges are made and are due within 15 days after the billing cycle. Accounts not reconciled by the 15<sup>th</sup> day will be paid via auto debit utilizing the credit card on file. If credit card on file does not accept the auto debit and the Member does not reconcile the account by the 30<sup>th</sup> day, charging privileges may be suspended and incur a finance charge of 1.5% on all past due charges. Members will also be held responsible for any legal fees incurred in the collection of their account.

Out of town guests of golf members have reduced rate green fees as described on the current rate sheet. Out of town guests of full family and swim or tennis members are eligible to have pool or tennis privileges at an established weekly rate.

Golf members may reserve tee times and carts up to 14 days in advance. Public patrons may not reserve weekend tee times before noon on Thursday.

Golf members may store their golf clubs at the Clubhouse for an annual fee. Members may rent lockers downstairs in the Clubhouse for an annual fee. Both privileges are subject to availability.

Golf members may have their handicaps maintained at Club expense.





## MEMBERSHIP POLICIES

Golf members receive a discount on the Jr. Golf program and golf lessons.

Pool and Social members may purchase an annual individual or family driving range membership.

Pool members may bring a guest for a fee set annually by the Board of Directors. The same person may be a guest seven (7) times per year.

Tennis members may bring non-members for a fee set annually by the Board of Directors. The same person may be a guest seven (7) times per year.

All users of the recreational facilities shall dress appropriately for the facility in use. Dress codes for each facility shall be established by the Board of Directors, General Manager or manager of the specific facility.

Members and non-members are to conduct themselves in a manner which will not interfere with others' enjoyment of Breton Bay Golf and Country Club. **Inappropriate or abusive behavior which impedes the ability of staff to perform their duties or is directed at other members/guests, is prohibited.**

The General Manager, or in his/her absence, his/her designee is empowered to act to remove, suspend or prohibit the use of Club facilities to members, board members and non-members for conduct detrimental to good order and the conduct of business.

Discipline for violation of policy or behavior deemed detrimental shall range from:

- 1) Letter of reprimand
- 2) Suspension for up to 30 days
- 3) Suspension for over 30 days to less than 1 year
- 4) Suspension of 1 year
- 5) Indefinite revocation of all access and privileges

When deciding the severity of punishment, the General Manager, or his/her designee, will consider the nature and severity of the offense, any previous violations, and any mitigating factors. All members subject to discipline under this policy shall receive a written letter from the General Manager or his/her designee. Members who wish to appeal the decision have the right to file a request of appeal to the Board of Directors within 30 days of the notification of discipline. Non-members have no right of appeal. Members are not released from their obligation to pay monthly dues during their term of suspension.

Membership and non-members use of the facility may be suspended or revoked for the following:

- a) Commission of any felony or misdemeanor at the Club

- b) Any theft from the club or any person at the Club
- c) Willful destruction of Club property or the property of any person at the Club
- d) Physical or gross verbal abuse of Staff or any person at the Club
- e) Conduct injurious to the reputation of the Club or its Members
- f) Violation of Club rules and/or conduct which seriously detracts from the Club Management's right to manage the Club and preserve its financial integrity
- g) Abusive language, drunkenness and disorderly conduct
- h) Assaults, affray or fighting
- i) Sexual harassment of any person at the Club. Sexual harassment is defined as, but not limited to, intimidating, offending or creating a hostile environment by sexual flirtations, touching, advances, verbal abuse of any nature, graphic or suggestive comments about any individual's dress or body, sexually degrading words and/or the display of sexually suggestive objects and/or pictures
- j) Dress code violations
- k) Bringing any animal onto Club property, whether leashed or attended, with the exception of Seeing Eye dogs or any other service animal

Memberships are renewable on an annual basis and are payable, in full, regardless of frequency of use by the member. The club membership year runs April 1<sup>st</sup> through March 31<sup>st</sup> of the following year. Partial forgiveness or refunds of dues may be granted to members who are moving out the St. Mary's County area, have incurred an injury or require surgery that precludes their ability to participate in the recreational activities of the Club. If a refund is deemed appropriate, refunds will be based on the following schedule:

Any member who is delinquent in payment of membership dues or other merchandise or charges for more than thirty (30) days is subject to suspension of privileges for use of the recreational facilities. Suspension of privileges will be determined by the General Manager or his/her designee. Suspended members are not entitled to a refund of membership dues for the suspended period nor does the suspension relieve the member from his/her dues obligation for the entire membership year.

The General Manager or other managers are granted authority to refuse service or access to the facility to any individual(s) where such action is deemed in the best interests of the Club.

Applications for membership may be reviewed by General Manager or the Board of Directors. Before membership status is granted.

The Board of Directors may choose to grant exception to any of these policies on either a one-time basis or for a longer term where such action is deemed in the best interest of the Club.
